- 9. Nomination and Possible Action on Hiring of New Town Attorney Noel Fox was nominated and unanimously voted to be hired as the new Town Attorney. She specializes in municipal government and also serves as the Town Attorney for Carolina Beach.

- 20. Flood Map Status Report Building Official Tim Evans Now looking at a January 2017 approval. The Town can't adopt the maps until the final letter of determination from FEMA is issued. There were six appeals in the Town.
- 21.Staff Report Terminal Groins The Corps of Engineers are not interested in an information session for the public at this point in time.
- 22. Central Reach Project Program Report and Request Workshop Date A tentative schedule for beginning the Central Reach project was presented. Sand placement on the beach would start this November. Vote to schedule a meeting in the next two weeks to discuss further passed unanimously.
- 23.Town Manager's Report The CRC approved the Development Line concept to be used in place of the static vegetation line/exception process. The Town was involved in this from the beginning. They also relaxed the use of sand bags. The canal inspections are complete. Storm decals were in this month's water bills. The odor problem is being addressed at the Jordan Blvd. sewer lift station. There have been vacuum problems with the sewer system the last few months. After investigation, it was determined that there is a problem with the vacuum pits that causes them to collapse. 700 of 1300 have been inspected and they are working to replace the faulty ones. The landscaping project on the mainland side of the bridge should be completed by June 17. The multipurpose court, dock and restrooms at the new Bridgeview Park should be completed by Memorial Day. The remaining items will wait until after the summer rush to be installed.
