Ronda Dixon: Why are we still considering Terminal Groin project after all BOC members stated they were opposed to this project during the 2016 campaign. Noted 2.5 years already spent on project since Draft EIS in addition to \$600,000 already spent.

Mark Fleischhauer: Inlet and Beach Protection Board proposal for consideration better than the one discussed last month. However, why have another board instead of using existing Parks and Recreation Board that already has the responsibility.

Unanimously approved inclusion of state funds into Town budget for dredging of all canals.

Solid Waste study presented by Town Manager (slides). Discussions by BOC members included various options such as island-wide rollback service, extending twice weekly pickups from May 1 to October 1, island-wide "opt-out" recycling program, and enforcement of number of cans per household requirements. Further cost studies to be completed by staff and presented to BOC at later date.

Unanimously approved to allocate \$9,000 to correct storm water drainage issue at Pointe West.
