Re: Proposed Parking Areas on Holden Beach

My family has owned property on Holden Beach since 1978 and I am a current homeowner on the Island. As a former Town Councilman and Chairman of the Planning and Zoning Board of another municipality in North Carolina this current endeavor sparked my concern.

I have always been impressed with the Holden Beach elected official's decision for so many years to have a height restriction on building structures on the Island. This restriction allowed Holden to have reasonable controlled growth yet keep the small community feel that I believe all homeowners and renters covet. So, I was concerned to learn that there is a desire to add 100 public parking spaces in residentially zoned areas on Holden. This will have a major impact on Holden Beach.

All decisions should be made with fact-based information and not on emotion. As a result, I have been searching for information that I am not finding readily available to homeowners. Please advise where to find the impact study, feasibility study, environmental impact study and the return on investment for the homeowner's tax dollars that are to be spent.

After listening to the February 5, 2021 Parking Committee meeting, the question was asked about rezoning the parcels in question. The answer given was that if the town considered a parcel "necessary for town use" no rezoning is required. I believe you are going down a slippery slope and in this situation a public rezoning hearing should occur and this property is no longer residential and should be rezoned.

It appeared after reviewing what was posted for the March 5, Parking Committee meeting, the purpose was to interview potential companies to operate public parking lots. So, are we to conclude this decision has already been made and the property owners/tax payers concerns are not going to be addressed?

Have you considered that a paved parking lot for public use may not be in the same character as a private home that is adjacent? Are these public lots in harmony with the adjoining properties? Fact: Based on an additional 100 public parking spaces, Holden Beach will provide the opportunity of adding 400-day visitors to our current population. This means 100 additional cars to our current traffic level. These 400 people that are not residents or island renters will require services. First, toilet facilities/bath houses are a must. Second, additional crosswalks and beach access will be needed. Third, lifeguards may be necessary to add to the town's staff. With that added volume of people, that is a liability the town needs to consider. Fourth, can the current water system handle the increased demand, or will the system need to be upgraded and at who's expense?

Also, to be considered, who benefits and who is harmed from this decision? Will this decision cause serious harm to landowners? Does the gain of having the parking lots outweigh the physical impact and financial impact to our citizens? What is the compatibility with the current uses of the adjacent properties? What is the impact on our road structures? How will this impact our police department? Is it in the town's best interest to spend taxpayer money(i.e. the property owners on Holden Beach) to provide services to those who do not pay taxes here at all? Is it not reality that money spent by day visitors is going to be off the Island with businesses that do not pay taxes to the Town of Holden Beach?

Homeowners that rent their homes from what I understand, usually have many repetitive renters. If they have a bad experience due to overcrowding, will they return?

I feel more public input is needed along with more information provided to homeowners before such a major decision is determined. This decision will have major implications for all of our citizens and could significantly impact their quality of life, safety, and financial security. The environmental impact is also an important consideration with the level of flooding that is currently happening in most of the areas that you have identified as potential good options for parking lots.

Providing information to homeowners is a necessity and warranted. An informed populous is extremely important on issues that could potentially impact their lives.

Thank you for your consideration and I look forward to receiving more data provided by you in the near future.

We are owners of a 2nd row rental property. We have enjoyed biking on the island and see many others doing the same on OB. Many bikers use the current sidewalk, which is also used by many persons taking a walk. This can create "close calls" when walkers are unaware of bikers approaching from behind. OB does not have "shoulders" that other roads sometimes have. Therefore, biking on the side/edge of the current paved road is taking one's life into the potential path of frequent traffic of service vehicles including large vans and trucks.

The addition of bike lanes will provide a separate "traffic lane" for bikers going faster than walkers, but slower than motorized vehicles. Providing bike lanes would also transmit a message from the town that we are concerned about the safety of guests who love to bike and supportive of a means of transportation that is not carbon-generating. Having a safe means of biking on the island may also promote more bike rentals from local vendors by guests.

The February minutes comment that pursuing grants to cover the cost could delay the paving of OB by the NCDOT. If our decision is further delayed, it will only reach a point when any grant application will become moot.

I'm sure you're bombarded with emails about this topic, but I thought I'd express my opinion as well.

While I understand what the community is trying to accomplish in curbing (see what I did there?) the unsightly trash bins up and down Ocean Blvd at all hours, I do have one point of concern with the proposal.

We live about 6 hours away and our time at the beach isn't necessarily as frequent as maybe some of the other owners. We often leave Sunday afternoons as we have work and sometimes school for the kids on Monday. My concern is that if the town imposed a 6pm night before rule on trash going out then our trash from Saturday and Sunday will potentially rot in our trash bin until the next time we come down which could be a month later. That would pose an even greater smell and potential safety hazard to the trash collectors as the bacteria grows and festers. 6:00pm also doesn't get us home until about midnight which isn't great either.

As an alternative, I'd like to propose 4:00pm Friday and a 4:00pm Sunday. That would work better for us and something we could easily work within.

Correl requirements: We live on a side street and most trash cans are in corrals near the roadway. We pull the cans out closer to the road. Thank you for sharing your thoughts on the proposed trash ordinance revisions.

The revisions are a reasonable attempt to improve the safety, sanitary conditions and property values on the island. As I said when introducing the revisions, they aren't meant to be a burden to anyone, but rather a benefit to everyone.

The Town now provides for everyone's trash receptacle to be returned to the house after pickup, so the only responsibility remaining is to place the can at the curb within the prescribed time frames. I believe that there are a number of options available to everyone, so we can all comply with the ordinance without insurmountable difficulty.

The proposal is an attempt to solve the very issue you cite related related to Saturday departures. If the proposal is adopted, I'm confident the renter or rental agent will find a way to comply in both prime and off season.

Waste Industries' contract with the town no longer provides for the removal or placement of receptacles in a corral. The receptacles must be curbside because they are emptied by use of a mechanical lifting device extended from the truck.

These comments are made mainly regarding proposed changes to trash concerns...just leave the policy as is....seems there are bigger issues to deal with than trying to penalize homeowners for trying to get their trash picked up. This policy overly penalizes homeowners who do not use their homes 100% of the time (which is way more than the majority of your homeowners). Some points I will suggest:

- 1. Homeowners should not have to schedule their home visit based on the trash pick up schedule.
- 2. Perfect example, this past Saturday afternoon, lots of trash cans out by the road until Tuesday pickup; these were either homeowners that went home on Saturday or renters that checked out Saturday morning which under the proposed rules would violate the 48-hour rule, thus a fine (rentals don't just occur during the summer).
- 3. Who is going to go along & determine if trash can is out by road in violation of time limitations? Are you going to hire someone to do this? Who is going to roll the full trash can back to house if trash has already been picked up if it is after roll back crew comes along?
- 4. While I would agree having trash cans out beside the road is unsightly & can be a safety factor, perhaps at a minimum, they could be left at edge of yard along the boulevard instead. We used to leave ours on the yard side of sidewalk & they would pick it up but now if it is not on sidewalk side, closest to road they will not pick it up.
- 5. When the cans are rolled back currently, they are rolled back to the front yard, not put on side if not raised home and in some cases around me, they are left in front yard even if raised home; they stay there until owners return unless a nice neighbor puts it back where it should go.
- 5. What works in another area does not always necessarily work for Holden Beach.
- 6. Let's move on from trash and talk about bike lanes which could be related. Speaking of bike lanes, if you put a 5 ft. bike lane between the sidewalk and the road on the boulevard, that is going to be a great obstacle course for the bike rider dodging trash cans (maybe supports my argument of putting cans at edge of yard).
- 7. It seems to me that the best solution is to have trash corrals (at least on boulevard though I am sure a lot would be opposed) and have trash removal company roll them from that point & put them back in corral (this way there would never be any cans out by the road, full or empty). I realize some people don't have a trash corral so would have to get one and the trash pickup service may not be willing to remove from corral, but it is worth trying over other proposed solutions). This would solve the unsightly display of cans by the roads & safety factor. This however would require the corral to be closer to edge of property, not 30 ft back.

I have owned the home at 143 Brunswick Avenue East for 19 years this May, have been a good neighbor, paid my taxes on-time, and never rented my vacation home. This year I have replaced the roof, windows, some siding, and am painting the exterior. I'm a responsible non-resident owner!

I am twice a widow with no children, and generally do not have guests unless I am also at the home with them.

I don't have a trash corral near the street. The wheeled bin is stored under the house. There are a few corrals on my street, but I don't consider them unsightly and they do NOT block my line of sight when I'm driving. Likewise, bins do not interfere with sight lines as long as they are placed on the property, not in the street. My neighbors do this - but the pick-up guys sometimes leave them in the street.

Odors should not be a problem if all units are required to bag all trash in bags treated with Febreeze. That would be a reasonable requirement.

Unlike those who rent, my trips from Charlotte to the beach vary according to the day of the week that I arrive and leave. I definitely object to the idea of being fined \$50/day during the rental season if I need to depart on a Wednesday, for example. There may not be many others with this concern, but the BOC needs to provide a central bin or dumpster that we can use in these situations.

If this is not done, the proposed fines are unacceptable to me, and I expect the Commissioners to vote <u>against</u> them. I suspect a few locals have been upset by some extreme violations, but I am quite sure the trash bins do not detract from the overall positive opinion owners and visitors have of our beach.

After reviewing the proposed changes I would offer the following comments.

Thank you for opportunity to provide comments on the proposed changes to the Solid Waste Disposal Policy. These comments are from the perspective of a non-full time resident but full time tax payer.

1. The requirements to place the trash can curbside no earlier the 6:00pm the day prior to collection and retrieve it no later then 3:00pm on the day of collection presents a challenge to non-full time residents. Our family, as well as many others, spend two weekends a month at Holden Beach normally arriving Friday and departing Monday. Prior to departing on Monday we place our can curbside on our property, but out of the right of way, around noon. The can has always been returned to our property and remained their until either we return or a neighbor moves it under our house.

We like many other non full time residents are fortunate to have good neighbors however they can not be designated trash can retrievers.

As written the proposed changes appear to unduly penalize non full time residents (which I would believe is a large portion of the Islands overall population). Implementation of this proposal, and it's proposed fines, will require non full time residents to either haul their trash away so the trash can is not left curbside or to adjust work and travel schedules in order to be present on trash collection day.

2. We would request that these impacts to non-full time residents be given consideration and implementation be delayed to allow further study.

We discussed the specifics of the proposed Trash Ordinance with 32 of neighbors. We believe it would serve our neighborhood & the town to retain the current Trash regulations while continuing to provide rollback service to all residents. Please Vote NO to the proposed changes due to the lack of support by property owners of all designations. After direct conversation with over all these neighbors NOT one agrees with the proposal. Our neighborhood is one of the oldest on the Island with a vast cross-section of Income levels, demographics and home values. Please feel free to visit and speak with our residents and homeowners on any topic.

The key factors cited as objectionable or Onerous

- 1. We believe Core Services should be the focus of your expenditure of Tax assets. 

The 30' setback requirement is arbitrary and unreasonable. Why not 25' or 20' or 15'. There is no magic number that is better than any other number. The problem is walkers dont want the cans near the side walk and owners dont want the cans near the house. I would propose making the cans halfway between the street and the house and require a corral that at least blocks the view on three sides. That would mean most owners who have corrals now would most likely meet the requirements. It also means the town doesnt have to roll them back twice as far. Only the most offensive situations would need to be corrected, like Leaving cans at the street. For properties like the Sea Oats Villas 104 Ocean Blvd east where there are multiple tenants it is not

For properties like the Sea Oats Villas 104 Ocean Blvd east where there are multiple tenants it is not possible to put them under the building. The only common area is in the sand area which would be a difficult task for tenants to roll them to the street so they are less likely to do it as well as difficult and time consuming for the town to put them back. We have new trash corrals that are attractive and hide the cans on three sides and we have bushes that help hide the corrals. There is no sidewalk on our side of the street so there is no impact on passerbys. There is absolutely no reason to require the cans be 30' from the road or under the building. That is arbitrary and capricious.

Concerns:

- Trash does smell, which is why some owners want the cans in a corral away from their house.
- The cans in the corrals are more secure from storms than when unsecured under a house. This is
 especially true for oceanfront homes.
- Many owners do not want the trash near their house because renters/guests occasionally dump
 hot ashes from grills or live cigarette butts in the trash. They are concerned about the fire hazard
 with the cans under the house and feel it is safer away from the structure.
- Trash near the home can attract pests such as insects and wildlife.
- Some homes use all the space under the homes for parking, taking a spot for trash cans violates
 the parking plan submitted when the home was built.
- Some owners feel the corrals work for them and their guests, they have used them for a long time and are happy with the arrangement.
- It is unclear that the Town can tell an owner where to keep their cans
- Unless it in the right-of-way, it is unclear that the Town can insist you remove your trash corral because it is not a structure, no permit was required to build it. Ironically, in the late 1990's the Town encouraged owners to build corrals as a solution to the trash problems at that time.

I see that that the town seems to be moving toward restricting when trash can be put out for pickup again. As noted last time the vast majority of homes at Holden Beach are owned by people who do not live there fulltime. They go to check their houses periodically and leave the beach on most any day of the week or weekend. When they leave they put the trash out for pickup (a service that we pay for with our taxes). It is unreasonable to expect owners or those using houses to leave only on Sunday or Monday if they have trash that needs to be collected. An owner going to the house for a few days to check on things, make repairs, arrange maintenance, etc. will likely not always leave on Sunday or Monday so if they cannot put out the trash, what is to be done with it. Does it remain to rot until a future visit in a month or two when maybe they can leave on Sunday or Monday?

If the commissioners are going to limit when trash can be put out they should also have a solution to deal with trash when people are leaving the beach on Tuesday, Wednesday, Thursday, Friday, and Saturday.

Another issue on Ocean Blvd. is that cans must be placed between the sidewalk and the road or Waste Industries will not cross the sidewalk to empty a can that is set near the sidewalk. Having to place the cans between the sidewalk and the road increases visibility of the cans and could be avoided if Waste Industries would empty cans positioned on the North side of the sidewalk.

As noted previously, I don't see why putting out trash for pickup when leaving the beach should be a problem (it hasn't been for 50 years) but if commissioners set a limited window, they have the responsibility to provide a reasonable solution for those who leave the beach on the other 5 days of the week.

Good Morning Heather!

This is for the Mayor, and the Board of Commissioners.

I am seeing evidence that a few members of the town board are once again working on putting rules in place about when, where, and for how long you can (and cannot) place your garbage cans on the streets for pick up.

So, here is my nickel's (maybe a dollar's worth) worth of input.

First, I DO understand where they are coming from. Riding down Ocean Blvd. on a Saturday morning (especially in the high season) is quite the sight. Too many of the weekly renters do not do their part to make sure the cans are out on Friday night for pick up early on Saturday morning. They don't really care that by the time they leave the garbage truck has already been by to pick up the waste. They are leaving... a mess. A mess that will stay in those cans, and sometimes on the street from Saturday until Tuesday. Yes, it smells. Yes, those cans can be traffic hazards. And yes, something should be done. However, I feel the wrong people are being punished with these new rules. Responsible homeowners. We are the ones who always follow the rules, but get lumped in with irresponsible renters. This issue falls squarely on the rental management companies, and those who rent their homes through other means, to people who are irresponsible. Those are the homes that look like landfills on Saturdays (and sometimes Tuesdays). The rental companies are going to have to have consequences either for tenants, or the town needs to give the agencies consequences. Before I was a homeowner, for years we rented weekly properties all up and down Holden Beach. We always read the information in the packets we were given, and we followed the guidelines. Re: Proposed amendments to Ch. 50 regarding solid waste

Please transmit to the Town Council in an appropriate manner the following comments on the proposed amendments to Chapter 50 of the Town's solid waste ordinances (the "Amendments"), which I understand are on the Board of Commissioners's agenda for their regular monthly meeting scheduled this evening, Tuesday, March 16.

My wife and I own a home on Holden Beach, in addition to our primary residence in Wake County. We are retired and spend part of our time in Holden Beach and part in our primary residence in Wake County. We have never rented our home out, and we have no plans to do so. However, our schedule is dependent on obligations without regard to trash pickup. In discussions I have had with others, our situation is reasonably common among other part-time residents on the island.

The provisions in the proposed language for 50.04(A) makes no adequate provision for compliance by persons in our position when it mandates that:

Containers will be located at streetside no earlier than 6:00 p.m. the evening before designated collection days during the summer rental season. For the rest of the year containers will be located streetside no more than 48 hours before the designated collection. All containers should be returned to the normal storage location by 3:00 p.m. the day of collection during the summer rental season and 6:00 p.m. the day of collection for the rest of the year.

Such requirements are often impossible to comply with for many people – like us – who own and enjoy dwellings that they visit occasionally. For example, if we leave on Sunday to be back to Raleigh the next morning, it will not be possible for us to comply with the 6:00 p.m. restriction during the summer rental season, as well as the 48-hour restriction the rest of the year. Likewise, compliance with the restrictions for timely returning the trash containers may be similarly impossible.

If the intent of the ordinance is to address safety hazards on Ocean Boulevard, those same concerns do not pertain on side streets less heavily traveled. Perhaps consideration should be given to distinguishing Ocean Boulevard, and perhaps even Brunswick Avenue, from the streets on which traffic is composed principally of residents on those streets. As to those residences, the proposed ordinance is unnecessarily heavy-handed and unduly burdensome.

Indeed, the effect of the ordinance is to perversely discourage ownership and use of second homes on the island. What is someone supposed to do with their trash when they are about to leave and it is well before the time allowed to place the cans near the street for collection? Rather than looking forward to returning to the beach, I can worry about whether we will be the subject of some enforcement threat or action by the Town. It is unreasonable for the town to put people in the position of leaving full trash cans under their homes because they can't meet the time restrictions for putting

the cans out for pickup and putting them back. This invites vermin, foul odors, and other unsanitary conditions under homes.

Moreover, the proposed ordinance may well be beyond the Town's statutory authority. While G.S. 160A-303.1 authorizes the enactment of an ordinance prohibiting the placement of cans on streets and condition that prohibition on the containers being "placed in a designated location or container," the statute nowhere provides for time limitations. Similarly, the statutes cited by Sec. 50.04 regarding enforcement (G.S. 160A-I 74, 160A-I 75, and 160A-193) provide no authorization for such limits, particularly where a significant portion of the private residences on the island are neither occupied by fulltime residences nor rented to third parties. As noted previously, the ordinance could lead to creation of nuisance conditions by forcing people to leave filled trash containers for extended periods under their homes. In addition to lack of statutory authority, an ordinance which is incapable of compliance through reasonable efforts by persons covered by it raises serious due process and equal protection concerns.

I strongly encourage the town to give additional consideration to the proposed amendments to the solid waste ordinance to ensure that it can be complied with by the large number of part-time residents on the island, who visit their homes on weekends and at other times. Enacting an ordinance that does not allow for such compliance hurts the attractiveness of Holden Beach as a location for those who neither rent nor live here full-time.
